(\*\* Specialist Position)**

Description of Duties:

The Criminal Division seeks a Deputy Attorney General for the Special Victims Unit in Sussex County. This Deputy Attorney General will handle a caseload primarily consisting of child death, abuse, and neglect cases, with some exposure to sex crimes prosecution. This Deputy Attorney General will attend victim interviews at the Children's Advocacy Center ("CAC") and conduct pre and post arrest intakes with investigators. This Deputy Attorney General will work closely with medical professionals, detectives and child welfare professionals to investigate child death, abuse, and neglect, and sexual assault cases; evaluate available evidence for charging; and prosecute crimes supported by the evidence. This Deputy Attorney General will share on call responsibilities with other Deputy Attorneys General to assist police with after hours investigations.

Strengths should include the ability to manage complex investigations; an interest in, and the willingness to learn and understand, medical evidence; the ability to evaluate criminal cases and exercise appropriate judgment in case charging and resolution; and the ability to anticipate issues in litigation with the ability to research legal and medical issues accurately and effectively. This Deputy Attorney General must be able to develop a good working relationship with detectives, medical personnel, child welfare professionals, other Deputy Attorneys General, support staff and Court personnel. This Deputy Attorney General must have the ability to independently try serious cases, and learn and apply relevant laws and court rules to cases.

**\*\*Internal Applicants** This **Specialist** position is per the Department of Justice Attorney Pay Plan V. Specialist Positions. The steps of DAG III Specialist, DAG IV Specialist and DAG V Specialist will apply to DAG positions in certain units and will be utilized to incentivize service in hard-to-fill positions or units in DOJ, as determined by the Attorney General or designee.
