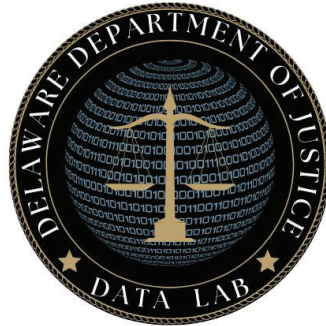

I prepared the following tables in response to your request for weapons charge and disposition statistics for 2015 through 2019. Using COGNOS, for each year in question, every case in which there was a firearm involved was compiled. The field was then narrowed to the specific sections of DE 11 that were requested (1442, 1444, 1447, 1447A, and 1448).

§1442 includes both DE1114420000FD and DE1114420000FG.

There are two tables for each year. In the first table, specific dispositions are reported (i.e. Discharged Probation Before Judgement, Dismissed, Guilty Original Charge, Not Guilty, Juvenile Found Delinquent, Juvenile Found Not Delinquent, and Nolle Prosequi). However, the complete disposition breakdown for each section for every year is included in the index.

At a superficial glance, it appears that the Department of Justice only prosecutes a fraction of the specified gun charges. However, accuracy demands a secondary analysis be conducted. By looking at the reasons behind the nolle pros designations, one can easily see that of the cases that were nolle prossed, the vast majority were ultimately prosecuted.

The second table provides the analysis of cases that were nolle prossed. For each section, the total number of cases, the number of cases nolle prossed, and the number of nolle prossed cases later prosecuted are displayed. Additionally, the percentage of the cases that were initially nolle prossed and the percentage once they were later prosecuted are presented.

¹ Establishing the percentage of cases nolle prossed by adding the five columns will yield the arithmetic mean or average of the number of cases nolle prossed (i.e. $52\% + 56\% + 70\% + 54\% + 62\% = 294/5 = 59\%$). While establishing the percentage by using the total number of cases not prosecuted versus the total number of cases will yield the actual percentage of cases nolle prossed ($1,595/2,732 = 58\%$.) In the interest of accuracy, the actual number is reported. The same is applicable for the total percentage prosecuted.

² Where there are instances of cases missing a status, the percentage of cases prosecuted was calculated in the manner least favorable to the DOJ. For example, in 2019, twenty-seven of 1447A cases were missing the reason for the NP designation. Since we are unable to affirmatively state that these cases were prosecuted, they were included in the number of cases not prosecuted (Of the 89 cases not prosecuted, 27 did not have a status).
